The Faulkner County Quorum Court met in its organization session at 7:00 PM on February 18, 2020 in Courtroom "A" located in the Faulkner County Courthouse with Judge James Baker presiding.

Invocation and the Pledge of Allegiance were led by Sheriff Tim Ryals.

Approval of the Journal: Justice Higgins moved that the journals of proceedings be approved as presented and such motion was seconded by Justice Goode and was unanimously approved.

County Officer's Report: Treasurer Scott Sanson reported to the Court on the financial status of the County and a copy of the report was provided to all members and one is on file.

Budget & Finance: Budget & Finance has met last week and has two (2) ordinances to present Under New Business.

Courts & Public safety: Met on February 11^h and Justice Higgins shared update regarding 911, the Circuit Clerk, Crystal Taylor's, update on Restoration Grant, Daniel Kneese update on proposed Animal Shelter plan and Justice Goode presented a Bill of Rights "Sanctuary" ordinance which was tabled for later discussion. Justice Higgins also announced he intended to schedule a Courts & Public Safety Committee meeting for February 25th to address a time sensitive issue brought to his attention by the Sheriff.

New Business:

The Court discussed Proposed Ordinance 20-04. This is an appropriation Ordinance to amend and supplement Faulkner County Ordinance 18-34. Justice Pickett made a motion to accept Proposed Ordinance 20-04 and to read Proposed Ordinance 20-04 by title only and Justice Goode seconded such motion. County Attorney Phillip Murphy read Proposed Ordinance 20-04 by title only. After discussion, Judge Baker asked for a vote by roll call for Proposed Ordinance 20-04. The roll was called and Proposed Ordinance 20-04 passed with a voice vote of 13-0.

The Court discussed Proposed Ordinance 20-05. This is an appropriation Ordinance to amend and supplement Faulkner County Ordinance 1948. Justice Pickett made a motion to accept Proposed Ordinance 20-05 and to read Proposed Ordinance 20-05 by title only, and Justice Pearson seconded such motion. County Attorney Phillip Murphy read Proposed Ordinance 20-05 by title only. After discussion, Judge Baker asked for a vote by roll call for Proposed Ordinance 20-05. The roll was called and Proposed Ordinance 20-05 passed with a voice vote of 13-0.

The Court discussed Proposed Ordinance 20-06. An Ordinance providing for the support of the Faulkner County Conversation District, to declare an emergency, and for other purposes. Justice Pearson made a motion to accept Proposed Ordinance 20-09 and Justice Higgins seconded such motion. County Attorney Phillip Murphy read Proposed Ordinance 20-06. After discussion, Judge Baker asked for a vote by roll call for Proposed Ordinance 20-06. The roll was called and Proposed Ordinance 20-06 passed with a voice vote of 12-1, with Justice Kendrick voting no.

The Court discussed Proposed Resolution 20-03. This is a Resolution designating Non-Profit Agency as CDBG Grant Administrator. Justice Pickett made a motion to accept Proposed Resolution 20-03 and Justice Pearson seconded such motion. County Attorney Phillip Murphy read Proposed Resolution 20-03. After discussion, this Resolution unanimously passed.

The Court discussed Proposed Resolution 20-04. Resolution authorizing Chief Elected Official to sign an application for CDBG Funds. Justice Higgins made a motion to accept Proposed Resolution 20-04 and Justice Goode seconded such motion. County Attorney Phillip Murphy read Proposed Resolution 20-04. After discussion, this Resolution unanimously passed.
