

PROPOSED ORDINANCE 21-16
Sponsored by Personnel & Budget & Finance

Be it enacted by the Quorum Court of the County of Faulkner, State of Arkansas. An Ordinance to be entitled: An Ordinance to reclassify job description based on level of experience and duties, increase pay for the employees of the Faulkner County Dispatch Center, increase in pay for the Chief Deputy of the Circuit Clerk and the County Clerk; and to declare an emergency.

- Section 1: Change to the County General Fund (1000), department 0400, Sheriff, Position Code 1053 – Dispatcher Supervisor to increase the position’s salary from \$36,343.84 to \$40,000.00. This will be an increase of \$3,656.16.

- Section 11: Change to the 911/PSAP Fund (3020), department 0501, 911/PSAP, Position Code 1287 – Dispatcher to increase the position’s salary from \$31,091.84 to \$34,000.00. This will be an increase of \$2,908.16.
- Section 12: Increase to position salary OEM Director, Position Code 1221 - County Road Fund (2000), department 0200, County Road from \$25,839.84 to \$28,339.84, which is an increase of \$2,500.00.
- Section 13: Increase to position salary OEM Deputy Director, Position Code 1224 - County Road Fund (2000), department 0200, County Road from \$43,276.48 to \$48,276.48, which is an increase of \$5,000.00.
- Section 14: Increase to position salary OEM Director, Position Code 1333 – 911/PSAP Fund (3020), department 0501, 911/PSAP from \$25,839.84 to \$28,339.84, which is an increase of \$2,500.00.
- Section 15: Increase to position salary 911 Deputy, Position Code 1289 – 911/PSAP Fund (3020), department 0501, 911/PSAP from \$40,125.28 to \$46,125.28, which is an increase of \$6,000.00,
- Section 16: Increase to position salary PSAP Deputy, Position Code 1288 – 911/PSAP Fund (3020), department 0501, 911/PSAP from \$36,343.84 to \$41,343.84, which is an increase of \$5,000.00.
- Section 17: Increase to position salary Chief Deputy Clerk, Position Code 1300 - County Recorder’s Cost Fund (3006), department 0120, County Recorder’s Cost from \$51,005.90 to \$56,700.00, which is an increase of \$5,694.10.
- Section 18: Increase to position salary Chief Deputy Clerk, Position Code 1005 - County General Fund (1000), department 0101, County Clerk from \$51,005.90 to \$56,700.00, which is an increase of \$5,694.10.
- Section 19: \$2,381.20 is appropriated to County General Fund (1000), department 0400, Sheriff, as follows:
